

Course Description

The Sport and Special Event Evacuation Training and Exercise Course will prepare sport venue managers to enhance evacuation planning capabilities and assist emergency responders in implementing flexible and scalable evacuation activities.

The highly-innovative course builds multi-agency collaboration by delivering critical evacuation planning information utilizing TOP Venue, a computerized modeling simulation and visualization training system. Participants will have the opportunity to conduct evacuation analysis of a sport venue under a wide range of conditions. Course will include plans and policies specific to respective sport venues. This course is applicable to all sport venues, regardless of venue capacity.

Topics

- · Using the Incident Command System (ICS) within the National Incident Management System (NIMS)
- The essential components of developing an evacuation plan for sport venues
- Incorporating the current operation strategies, organizational structures, and methodologies used by evacuation personnel
- Training exercise involving key partners that identifies and address gaps to achieve a high level of preparedness for evacuations
