Alternate/Substituions

In the event a qualified contestant is unable to compete due to extenuating circumstances (illness, injury and ineligibility), it is the responsibility of the school of the indisposed contestant(s) to notify Kathleen Navarre (kathleen@asaa.org) by the deadline on Wednesday, Nov. 5 at 11:00 AM. Once notified, ASAA will invite the next athlete with the best qualifying time/score. After the deadline, the spot will not be filled.

- **Relays:** All team members originally named in the conference relays, up to 8, not only those who swam, are eligible to be placed in the relay after the Wednesday deadline following all NFHS rules for relay alternate swimmers.
- **Divers:** Alternates that are invited to state meet must submit dive sheets at the time of accepting the invite. First and second alternates can submit dive sheets early in case they become participants.

PASSES

Issued to certified coaches and rostered participants.

Admin passes available on arrival

Fines issued for misuse: \$25 for coaches, \$10 for participant

RESULTS

Will be posted online as soon as possible or following the events each day. Results will be on the Swim & Dive section of the <u>asaa.org</u> website.

APPEALS

A jury of appeals is appointed by ASAA and the Meet Director.

The jury has the final say on any appeal submitted by a head coach (Use form in packet).

MEDICAL

Medical coverage will be provided by Municipal of Anchorage certified life guards.

PHOTOGRAPHY/VIDEOGRAPHY

ASAA credential media only will be allowed on the pool deck.

Schools may request one team photographer for admission to meet, but they will not be allowed on pool deck.

EVENT SUPERVISION

Each school must designate an administrator to oversee team and fan conduct Check in with ASAA staff required (ASAA bylaws Article 6, Section 4, State Championship Policies #22)
